

MEMBERSHIP RULES OF JIT SIN ALUMNI SINGAPORE

新加坡日新校友会会员条规

The following clauses are extracted from Constitution which are relevant to the membership of the Alumni. Please refer to the Constitution for more details.

MEMBERSHIP

4.1 Membership is restricted to residents of Singapore. There shall be 4 categories of membership:

- Ordinary membership
- Junior membership
- Associate membership
- Honorary membership

4.2 All former students of the Jit Sin Schools above the age of 21 years may apply for Ordinary membership

4.3 All former students of the Jit Sin Schools above the age of 18 years but below 21 years may apply for Junior membership.

4.4 The immediate family members of Ordinary members may be eligible for Associate membership. Their membership will terminate once the Ordinary member of the family ceases to be a member. Immediate family members refer to the legal spouse and children who are not former students of the Jit Sin Schools.

4.5 The retired staff of the Jit Sin Schools and persons with special contributions to the Jit Sin Schools or the Association may be appointed by the Management Committee as Honorary members. These contributions may include active involvement in the Management Committee or sub-committees in organising the activities of the Association, or in the development of the Jit Sin Schools.

4.6 Members shall have the right to participate in the Association's activities.

4.7 Only Ordinary members shall have the right to speak and vote at all general meetings of the Association, and to hold office in the Association.

4.8 All members shall abide by the rules and resolutions of the Association. They shall contribute to the promotion of the Association and assist in its functions and activities.

APPLICATION FOR AND RESIGNATION FROM MEMBERSHIP

5.1 All applications for membership shall be submitted to Hon. Secretary on a prescribed form. The Management Committee may, at its discretion, accept or reject any application.

5.2 Any member who wishes to resign from the membership of the Association shall give one (1) month notice in writing to the Hon. Secretary and shall pay up all dues.

ENTRANCE FEE

6.1 The entrance fee for Ordinary memberships shall be SGD50.00, and shall be determined by the General Meeting on recommendation from the Management Committee from time to time.

6.2 Once the entrance fee is paid and the membership is approved by Management Committee, there shall be no further subscription. All entrance fees shall be made payable to the Association upon application for membership.

6.3 There shall be no entrance fee payable by Associate and Honorary members. There shall be no subscription fee payable by all members.

6.4 The income and property of the Association whensoever derived shall be applied towards the promotion of the objects of the Association as set forth in this Constitution and no portion thereof shall be paid or transferred directly or indirectly by way of dividend or bonus or otherwise howsoever by way of profit to the persons who at any time are or have been members of the Association or to any of them or to any person claiming through any of them.
